a cohort that spends seven weeks of their summer in Washington, D.C. Each Scholar is placed in a full-time internship for the duration of the program. Capitol Scholars *also* have the unique chance to be exposed to a wide variety of views by engaging in various external meetings with members of the Alabama delegation, governmental affairs agencies, and more.



INTERNSHIPS

Once selected, Scholars' placement decisions are determined by UAS Governmental Affairs and governmental offices' requests and vary each year.

My internship at Van Scoyoc
Associates tied all of this together.
Whether I was preparing morning
briefings on agency actions, tracking
federal nominations, or sitting in on
client calls, I constantly saw examples
of our unique system of government at
work. It became clear to me that
separation of powers isn't just an
academic concept—it's the framework
that guides every decision, every
negotiation, and every line of policy.

Seeing it in action

taught me how real leadership requires balancing ambition with restraint, and authority with humility.



I have experience in research, but before this summer, I had never dealt with such rapid turnaround times. At VSA, I conducted lots of hearing coverage: taking extensive notes, compiling them, and writing detailed memos to be sent out to clients and members of the firm. Often, I had less than a day to finish a project. This new experience was extremely beneficial; I had the chance to quickly hone my writing skills. I am certain this will behoove me immensely as I enter the equally

fast-paced environments

of law school and the legal field. I have learned more about the appropriations process and federal appellate litigation than ever before, and this directly correlates to my potential future career in appellate law. Familiarity with these processes will help me navigate fields with which I would otherwise be wholly unfamiliar.



Working in Congressman Aderholt's office taught me extensively about working in government and, further, reaffirmed my desire to work in or alongside government. Seeing the focus on constituents and learning how different groups, including nonpartisan researchers, come together to achieve different goals has

confirmed my passion for policy

and strengthened my interest in returning to D.C. in the future. This experience has also empowered me and helped me build connections that I believe will be valuable if I decide to come back to D.C. to work. Spending each day on the Hill allowed me to see day-to-day operations up close, learning how the office navigates challenges while serving constituents.

Working in the press and communications allowed me to participate in meetings that were mostly not yet available to the public. I have learned that the federal government is somehow simultaneously the fastest and slowest-paced environment I have ever been in.

I loved every minute of it.

One such experience I had was researching, analyzing, and annotating a project. The contents went straight to the committee. I felt a sense of importance and pride in being able to contribute to something so relevant.





My work with Mountain View Partners showed me how lobbying, when done transparently and in the public interest, is another critical check in the system. It represents how civil society

participates in the policy process,

applying pressure and providing information that can shape outcomes across all branches of government.

I was able to get

hands on experience

in the authorization and appropriation processes during a critical time: when the bill moves through Congress.

Working at a time like this has been monumental. In 7 weeks, I was able to fully immerse myself, now I have a much better understanding of appropriations and Congress.



Scholars work at their respective full-time internships for the duration of the program. What makes the Capitol Scholars Program unique is its additional external experiences, through which Scholars are exposed to an incredibly diverse set of perspectives and professions.

MENTORSHIP PAIRINGS

Each Capitol Scholar is matched with a mentor a career professional in their corner to answer questions and provide individualized guidance throughout the program.

Through these meetings, the Program exposes its Scholars to the widest possible variety of governmental perspectives. Scholars meet and engage with members of the Alabama delegation, governmental affairs agencies, and UA System alumni.




Visiting places like RAND, the American Enterprise Institute, the Bipartisan Policy Center, the U.S. Chamber of Commerce, and the Supreme Court exposed me to a wide range of perspectives on public policy, research, and governance. Hearing directly from experts and leaders at these institutions helped me understand how policy is shaped not just within government, but by the ecosystem around it—think tanks, advocacy groups, and the private sector.

Recall: these external events happen simultaneously with the full-time internships. Supervisors are aware of the unique CSP schedule and allow Scholars to leave work to attend external meetings and events.

Before coming here, I had a general understanding of what think tanks did, but actually seeing the inner workings of both organizations was eye-opening.
